What is Community Benefit?


The IRS has federal requirements for nonprofit hospitals like Good Samaritan Medical Center to report their investments in Community Benefit activities which are programs or activities that provide treatment and/or promote health and healing as a response to community needs:

- Improve access to care
- Enhance the health of a community
- Advance medical or health knowledge
- Reduce the burden of local, state, federal government, or other community efforts


When reporting to the IRS, Community Benefit investments are organized into the following general categories:

- Unreimbursed costs for care provided to Medicaid beneficiaries
- Charity care and financial assistance for patients who are unable to pay for care
- Cash and in-kind contributions to support identified community health needs
- Health professions education, including clinical training for nursing, pharmacy, and other health professions
- Subsidized health services, which are services provided at a loss but without which the community's access to care would suffer
- Means-tested government programs, which includes the unreimbursed care under means-tested programs like the Child Health Plan Plus (CHP+)
- Community-building activities, including participating in community coalitions to advance health and physician recruitment to maintain health care access
- Research includes studies or investigations that increase knowledge made available to the public (Note: No Research investments were reported in 2022)
