As part of our commitment to Miles City and the State of Montana, Holy Rosary Healthcare improves the health of the communities we serve, especially the poor and vulnerable. The Sisters of Charity of Leavenworth developed innovative ways to provide healthcare in their communities more than 150 years ago. Through a comprehensive assessment of community needs and strong local collaborations, we strive to continue that work today.

Comprehensive Cancer Care for Eastern Montana

Cancer patients in eastern Montana often face traveling long distances to receive radiation oncology treatments. With support from a \$6 million grant from The Leona M. and Harry B. Helmsley Charitable Trust, Holy Rosary broke ground in April for a new 12,000-foot facility that will be the only comprehensive cancer center within a 125-mile radius. The total cost of the project is \$17 million and expected completion is late 2024. It will provide medical and surgical oncology as well as radiation services that will change the landscape of access to healthcare in rural Eastern Montana.

"There is not a single day that I don't feel thrilled to be a cancer survivor," said Dee Abbott, a Miles City

resident who traveled a long road in every sense of the word for her journey to remission. She was diagnosed with breast cancer in March 2022 and her aggressive treatment plan required a regular 300-mile roundtrip between Holy Rosary, St. Vincent Healthcare, and her home. During the winter, it was necessary to stay in Billings Monday through Friday for five straight weeks for radiation. "Most often, I was there by myself. Leaving Miles City meant I had to leave

The cancer center will allow community members in eastern Montana to stay closer to home as they receive lifesaving care. "Holy Rosary has a long legacy of providing high-quality cancer care, including medical and surgical oncology, survivorship programming, and other health and wellness services," said Karen Costello, President of Holy Rosary Healthcare. "This center is an example of our commitment to increase access and expand services like radiation oncology to our communities."

What is Community Benefit?

Community benefit is integral to the mission of Catholic and other not-forprofit hospitals. It is an extension of our 'historic mission to the communities' especially the vulnerable and disenfranchised. The IRS has federal requirements for nonprofit hospitals like Holy Rosary Healthcare to report their investments in Community Benefit activities, which are programs or activities that provide treatment and/or promote health and healing as a response to community needs:

- Improve access to care
- Enhance the health of a community
- Advance medical or health knowledge
- Reduce the burden of health care on local, state, of federal government


When reporting to the IRS, Community Benefit investments are organized into the following general categories:


 Unreimbursed costs for care provided to Medicaid beneficiaries

- Charity care and financial assistance for patients who are unable to pay for care
- Cash and in-kind contributions to support identified community health needs
- Health professions education, including clinical training for nursing, pharmacy, and other health professions
- Subsidized health services, which are services provided at a loss but without which the community's access to care would suffer

- Means-tested government programs, which includes the unreimbursed care under means-tested programs like the Children's Health Insurance Plan
- Community health improvement services, including health screenings and community health education
- Community building activities, including economic development efforts and other community supports
