This annual report is our opportunity to express our sincere gratitude to all who invested this past year in St. Mary's Medical Center's mission to reveal and foster God's healing love by improving the health of the people we serve, especially those who are poor and vulnerable.

2022 was quite the year for both St. Mary's Medical Center and the St. Mary's Hospital Foundation!

It was a record-year for the Foundation, with contributions totaling over **\$5.5 million**, the **most raised in a single year**, and a year over year increase over the past five years. However, it is not about the dollars but more about the lives that have been impacted, and in 2022 you made quite the impact!

It is truly because of your compassionate investment in our mission, St. Mary's Medical Center continues to strengthen its patient services and provide quality care.

Throughout this annual report you will see many highlights of the exciting things you helped to accomplish. These include:

- Joining our partners Meals on Wheels and Food Bank of the Rockies to cut the ribbon on a new
 50,000 square-foot warehouse. This included an expanded commercial kitchen and office space for Meals on Wheels and was made possible with
 \$675,000 in new grant funding and major gift contributions. This new space will increase the program's capacity to prepare and deliver 1,000 healthy meals to older adults in Mesa County.
- Hosting the inaugural Scholars' Luncheon, distributing \$12,000 in scholarships to ten St. Mary's caregivers. These Funds were made possible through the establishment of St. Mary's first scholarship endowments: the Kathleen McGinniss-Feinzig, MD & Herbert Feinzig Education Endowment and the LeAnn & Les Zetmeir Education Endowment.

• Welcoming back the St. Mary's Ball after a 3-year hiatus and joining 600 of our closest friends as we raised funds for the newly established Caring for the Caregiver Fund which supports the well-being of our caregivers through education, social support, and self-care activities.

These are just a few of the things our community has helped to accomplish, but philanthropy does so much more to support the health of our friends and neighbors...YOU do so much more.

From the cancer patient you helped to get a new hot water heater to the Neonatal ICU mom that stayed at Rose Hill House.... to the COVID patient needing a wheelchair at home while they recovered.... From every patient served we say, "thank you."

It is truly because of your compassionate investment in our mission, St. Mary's Medical Center continues to strengthen its patient services and provide quality care. There are many more exciting things to come in the year ahead, and we are grateful to you for being a part of it. Investing in our Healers St. Mary's Foundation Celebrates First Scholarship Recipients

At St. Mary's Medical Center, our caregivers are our most valuable asset. With more than 1,700 full-time equivalent staff and over 500 physicians, we strive to meet the ongoing and emerging educational needs at all levels to create the most talented healthcare workforce possible.

Through the St. Mary's Hospital Foundation and the generosity of our donors, we aspire to strengthen and enhance the capacity for education, practice, quality and retention by increasing educational and scholarship opportunities for those caregivers pursuing advanced degrees, bachelor's degrees and specialty certificates.

In 2022, St. Mary's Hospital Foundation hosted its first Scholars' Luncheon distributing \$12,000 in scholarships to ten St. Mary's caregivers. Funds were made possible through two scholarship endowments that were established in 2020.

The Kathleen W. McGinniss-Feinzig, MD & Herbert J. Feinzig Education Endowment

Herb Feinzig grew up the son of immigrants in a working-class neighborhood in Brooklyn. Due to a unique New York scholarship program, he was able to attend Brooklyn College essentially tuition free. This remarkable opportunity compelled Herb to provide the same opportunity to others. "Scholarships enabled me to succeed in a way I would not have otherwise," says Herb.

While Kate didn't utilize scholarships when she was working toward her medical degree, she wholeheartedly shares Herb's beliefs. Kate explains,

"By having a college degree, a person has many more choices in life. Getting that education gives them additional opportunities they may not have had."

The Feinzigs say their choice to invest in St. Mary's Medical Center came easily. By establishing St. Mary's Medical Center's first scholarship endowment, they combined their interests in education and medicine, and they strongly believe in St. Mary's mission. "St. Mary's serves the community exceptionally well. That excellence in care comes from having well-educated and committed staff," explains Kate.

Serving the community is another reason the Feinzigs see real value in providing these scholarships. They believe scholarship recipients go on to help others in the community and beyond. "The recipients improve their lives, their children's lives and all those that are touched by their successes."

The LeAnn & Les Zetmeir Education Endowed Fund

LeAnn and Les' connection with St. Mary's Medical Center began with the births of their children. Since then, the couple welcomed two grandchildren at St. Mary's, Les received lifesaving care, and LeAnn serves on the Foundation Board.

"The more we know about the hospital's inner workings, the more we love them," Les says.

Throughout 50-plus years in Grand Junction, the Zetmeirs have found St. Mary's commitment to community health consistently impressive. "St. Mary's is there to help everyone — no matter what their needs are," LeAnn says.

Both retired from the financial services industry, the Zetmeirs believe financial contributions should start early, especially charitable ones. That's why they established an endowment providing scholarships for St. Mary's caregivers wishing to further their medical education.

As the Zetmeirs say, a happy, well-educated staff in a medical center helps create an environment where patients can feel safe and heard and get healthy. "We wish everyone could see value in giving time and treasure," LeAnn says. "The more you give, the more you get back."

Death brings unique sorrow, and Tom Huerkamp's passing was no different. In his life, he was the founder of ProSpace Interiors, and an avid philanthropist. In his memory, the Estate of Tom Huerkamp generously gifted \$50,000 to St. Mary's Foundation. The money established the ProSpace Interiors Education Endowment and will provide caregiver scholarships.

Caregivers employed by St. Mary's Medical Center can apply for these funds and further their education.

Dave Huerkamp, Tom's brother and long-time Foundation board member, helped organize the gift. For the brothers, who grew up in a small town and Catholic environment, the vision of St. Mary's resonated. "The mission of St. Mary's hospital, to serve those in need, especially the poor & the vulnerable, aligned with our philosophy of helping others and giving to those in the greatest of need," said Dave.

Carmen Shipley, Executive Director of the St. Mary's Foundation, expressed gratitude for both Tom and Dave Huerkamp. She pointed out how their decades of support has helped the Foundation carry out its mission.

"It is a wonderful way to memorialize the impact Tom made not just here at St. Mary's Medical Center, but all across the Western Slope," said Carmen.

The ProSpace Interiors Education Endowment will provide individual caregiver scholarships of \$1,000 or more. Caregivers seeking to further their education can apply for the scholarship starting in spring 2024.

Nontraditional students returning to school or entering post-secondary education often face financial hardships. The endowment will help St. Mary's caregivers focus less

on fiscal strain and more on academic pursuits.

Carmen recognized the importance of supporting continuing education of the current and future health workforce. "St. Mary's is dedicated to creating opportunities for St. Mary's caregivers to further their education in the healthcare industry in an environment that is close to home," she said.

In 2019, the ProSpace Interiors Team was selected as the St. Mary's Hospital Corporate Citizen of the year. The honor was one of several ways the team has and continues to support St. Mary's. Another is through Dave's spot on the St. Mary's Foundation scholarship review committee.

"I have seen first-hand the financial need of some of these caregivers wanting to improve their education and skills," said Dave. "That is why we decided to partner with the St. Mary's Foundation to create a permanent endowment that will continue to support the educational needs of these dedicated caregivers."

"Philanthropic funds go a long way to ensure St. Mary's caregivers are properly trained and continue to learn the latest in healthcare advances, while simultaneously providing high-level and compassionate care," Carmen said.

"When Tom passed away, it was his wish to create a legacy of support for those people that have dedicated their lives to improving rural healthcare," said Dave. "It is our hope that the new ProSpace scholarship will help support the critical continuing education of these dedicated healthcare professionals that give so much to our communities every day."

St. Mary's Ball Supports Caregivers

The St. Mary's Ball returned after a two-year hiatus on October 1 at the Grand Junction Convention Center. Over 600 people attended the event to celebrate community heroes, including Dr. Bill Hilty as the Dr. Geno Saccomanno Physician of the Year Award recipient, Nikki and Mike Blackburn as the Sister Michel Awardees for Philanthropists of the Year, and Wanebo Love Keller Mendenhall Smith Wealth Management Group as the Corporate Citizen of the Year. Event proceeds benefited the Caring for the Caregiver Fund.

To enhance and sustain the health and wellbeing of our clinical workforce, the St. Mary's Foundation Board created the Caring for the Caregiver Fund as a resource for our clinical leaders to develop creative solutions to promote caregiver resilience and replenishment through education, social support, self-care activities, and meaningful recognition.






Measures of Impact for 2022

Transferred to St. Mary's Medical Center




Total Caring Spirit (employee giving) donations




Tribute gifts are given in honor or memory of a special person – perhaps a caregiver, family member, or friend. They are given in thoughtful remembrance of a life; in recognition of a special occasion; or in appreciation of service. These tributes serve as a permanent expression of love, honor, and recognition.

Endowments

Endowments are invested for growth and income in a diversified portfolio and are strategically managed. Each endowment distribution is used according to the donor's intent as outlined in a formal agreement between the donor and the Foundation. Funds earned from an endowment may support a program and are distributed to the hospital annually in accordance with the policies established by the Hospital Foundation.

Real Estate

The Hospital Foundation accepts gifts of real estate, including houses, condominiums, commercial properties, farm land, rental property, and undeveloped land after a thorough review of the property and its potential usage by the Foundation.
