Our founders, the Sisters of Charity of Leavenworth, developed creative ways to provide healthcare in their communities more than 150 years ago. Through strong community partnerships and thoughtful assessment of needs, we continue that work today.

Investing in Montana's Mothers and Babies

Sarah Shannon, PhD, RN, FAAN, Dean of the Montana State University Mark and Robyn Jones College of Nursing, shares some startling statistics related to the health of pregnant women in the state: Montana has the sixth-highest rate for maternal mortality in the U.S., and

only 66% of women in rural Montana receive adequate pre-natal care. To change those statistics, St. Vincent Healthcare has committed \$3 million to permanently endow the college's new certified nurse midwifery (CNM) program.

St. Vincent has offered CNMs as part of its evidence-based mother-newborn care since

1990, including CNM outreach programs on the Northern Cheyenne reservation to improve pregnancy outcomes in the reservation community.

The endowment from St. Vincent will help cover some of the most expensive aspects of the CNM training, reducing the program's cost for students. The endowment will improve access to the program for more Montana nurses and increase the availability of certified nurse midwives in Montana communities.

"Moms and newborns in rural communities need rapid access to specialized maternal services," Shannon said, noting that CNMs can assess when a pregnant woman or baby is in danger. "Early identification saves both mothers' and babies' lives."

2020-2023 Community Health **Priorities**

Every three years, St. Vincent partners with public health, other health care providers, and community members to assess the most important health needs in the community. Following the assessment, the hospital chooses health priorities on which to focus our community benefit efforts.

What is Community Benefit?


The IRS requires nonprofit hospitals to report their investments in Community Benefit activities. These are activities that respond to an identified community health need and:

- Improve access to care
- Enhance the health of a community
- Advance medical or health knowledge
- Reduce the burden of local, state, federal government, or other community efforts

When reporting to the IRS, Community Benefit investments are organized into the following general categories:

- Charity care and financial assistance for patients who are unable to pay for care
- Unreimbursed costs for care provided to Medicaid beneficiaries
- Cash and in-kind contributions to support identified community health needs
- Other means-tested government programs, unreimbursed care, like the Children's Health Insurance Plan
- Health professions education, including clinical training for nursing, pharmacy, and other health professions
- Subsidized health services, which are services provided at a loss but without which the community's access to care would suffer
- Community health improvement services, including health screenings and community health education
- Community building activities, including economic development efforts and other community supports
- Research includes studies or investigations that increase knowledge made available to the public
