As part of our commitment to Mesa County and Western Colorado, St. Mary's Medical Center addresses the most critical needs of the communities we serve; with emphasis on those who are poor and vulnerable. Our founders, the Sisters of Charity of Leavenworth, developed creative ways to provide healthcare in their communities more than 150 years ago. Through strong community partnerships and thoughtful assessment of needs, we continue that work today.

Addressing housing to improve health

Homelessness has many causes, and it is correlated with many of the social determinants of health that play a big part in people's health and well-being. Housing insecurity, food insecurity, physical safety, access to healthcare, access to education, economic security, and more are all impacted by and contribute to homelessness.

St. Mary's has long supported Homeward Bound, a leader in addressing homelessness in Mesa County. That supported has included a cash gift of \$300,000 to help build the new Pathways Family Shelter, in addition to more than \$35,000 worth of free laundry services annually to help the shelter provide clean linens for its residents.

Starting in 2021, St. Mary's expanded its support of Homeward Bound. Working in partnership with Colorado Mesa University, St. Mary's

caregivers are providing on-site primary care services at the shelter to make sure that everyone who stays there has access to health care.

"This new partnership aligns with the prioritized community health needs in Mesa County," said Gretchen Gore, Vice President of Mission Integration for St. Mary's. "Our goal is to address or help prevent underlying health issues or chronic disease that would otherwise hold people back."

What is Community Benefit?

The IRS requires nonprofit hospitals to report their investments in Community Benefit activities. These are activities that respond to an identified community health need and:


- Improve access to care
- Enhance the health of a community
- Advance medical or health knowledge
- Reduce the burden of local, state, federal government, or other community efforts

When reporting to the IRS, Community Benefit investments are organized into the following general categories:


- Unreimbursed costs for care provided to Medicaid beneficiaries
- Charity care and financial assistance for patients who are unable to pay for care
- Cash and in-kind contributions to support identified community health needs
- Health professions education, including clinical training for nursing, pharmacy, and other health professions
- Subsidized health services, which are services provided at a loss but without which the community's access to care would suffer

- Means-tested government programs, which includes the unreimbursed care under means-tested programs like the Children's Health Insurance Plan.
- Community building activities, including economic development efforts and other community supports
- Community building activities, including participating in community coalitions to advance health and physician recruitment to maintain health care access
- Research includes studies or investigations that increase knowledge made available to the public
